## Changes to the 2017 Physician Incentive Program

Partners For Kids has learned that the Ohio Department of Medicaid (ODM) is planning to implement a single preferred drug list (PDL) effective January 1, 2018. This PDL has not been finalized, but there is potential to impact your patients, your practice and the pharmacy shared savings program in the PFK physician incentive program (PIP). It is anticipated that some of the PFK preferred medications may move to the non-preferred list and vice-versa. Due to its chronic nature, changes to the ADHD medication PDL are likely to be the most impactful to your patients and families. PFK is stepping back from its activities surrounding ADHD prescribing given these changes. We will update you directly as we learn more. This information was reviewed with the PFK Physician Incentive Committee at its meeting on September 21.

# **Paramount Advantage Updates**

Claim adjustments of previously adjudicated claims may be submitted electronically by using claims frequency codes in compliance with ANSI (American National Standards institute) 837 claim format. Adjustments will be accepted with Frequency Code 7 (Replacement of Prior Claim) or Code 8 (Void/Cancellation of Prior Claim). The original claim number, along with the claim frequency code, must be submitted or the form will be returned. The original claim number may be obtained from the EOP (Explanation of Payment) to include the service which needs reconsideration. Please be aware that claim adjustments with attachments can only be submitted on paper by filling out the Claims Adjustment/Coding Review Request which is attached for your convenience. ## PFK Asthma Medication Ratio Practice Facilitation Project

PFK is offering free support for community practices through the Practice Facilitation of Quality Improvement (QI) program in efforts to improve overall asthma management. The new asthma QI program focuses on improving your patient's asthma medication ratio which is a validated predictor of asthma ED visits and hospitalizations. Furthermore, practices will work with PFK's practice facilitation team to implement and/or improve their approach to asthma management for their patients. This includes Asthma Control Test administration, Asthma Action Plan development and updates and routine follow-up visits. Participating practices will benefit by not only improving the overall asthma care of patients, but will also receive support PFK staff and NCH subject matter experts, access to PFK data and Part IV Maintenance of Certification Credit. ## Did you know?

Partners For Kids has made a change to the process for collecting proof forms from our practices. Proof forms have been used quarterly by practices who had seen patients marked as non-compliant to provide evidence that these patients are compliant and the physician should have been paid a bonus. Independent of the proof forms, Partners For Kids performs an annual "True Up" calculation each August, which is a final sweep of the previous year's claim data. Both of these processes help to ensure that a provider receives their bonus for any claims that may have been paid late.

An analysis of proof forms received for 2016 claims found that the majority of submitted forms would have been caught by the True Up calculation. Since submission of proof forms is a labor-intensive process for practices, PFK is accepting proof forms <u>once</u> per year after the True Up calculation is completed. The proof forms for 2017 claims will be accepted will be in August or September of 2018.
