Welcome Partners For Kids New Medical Director

Gilbert Liu, MD, MS, has joined Partners For Kids as our new medical director. Dr. Liu comes to Nationwide Children's Hospital from the Kentucky Department of Medicaid Services where he was the chief medical officer. He was also the Foundation for a Healthy Kentucky Endowed Chair of Urban Health Policy Research and a professor in the University of Louisville School of Medicine.

In addition to his pediatric clinical training at the University of North Carolina, he completed a master's degree in biomedical engineering and fellowship in medical informatics. Dr. Liu is passionate about improving communities and has a track record of developing programs that serve children and engage community champions. Dr. Liu and his colleagues applied numerous federal research grants to study neighborhoods, and modify environmental factors associated with chronic conditions of childhood. Dr. Liu developed collaborations with the medical school and university, public officials, city government, community organizations and a local school district.

Ohio Department of Medicaid Re-Procurement Process

In February, Gov. DeWine asked the Department of Medicaid to initiate a re-procurement process. This means that the state will ask managed care companies to submit bids to manage the managed Medicaid Program in Ohio. Gov. DeWine said he wants to ensure Ohio taxpayers are getting the best value from the managed care contracts. The bid process will be open to the current payors and any new payors wishing to enter the Managed Medicaid market. The number of bids that will be awarded is not known at this time. The process will begin with Ohio Department of Medicaid (ODM) meeting with key stakeholders to define the services and other requirements for bids. Providers are likely to receive invitations to join provider networks from payors that are interested in submitting bids. Partners For Kids intends to participate with the health plans that are ultimately chosen by ODM, so no additional action is required from Partners For Kids providers at this time. The last re-procurement process occurred in 2011 and took approximately 18 months.

Even if you choose to not accept new patients and have zero capacity, being credentialed with all five plans may help maintain the continuum of care for patients. This could also help your practice be reimbursed for services and avoid the possibility of providing care to them without realizing they changed managed care plans.
