Training Audience Key

General: Training topic and content is applicable to staff with a broad range of education and experience.

Topic: [The Impact of Marijuana Use on Adolescents](#)

Presenters: Mary Fristad, Ph.D., ABPP and Natalie Powell, LPCC-S, LICDC-CS

Description: The first part of this training will provide clinicians with information on current trends in legalization of medical and recreational marijuana in the United States, explore the biology of cannabis use on the adolescent brain, and describe the risks and benefits of use. The



latter portion will describe clinical strategies and evidenced based interventions for addressing problematic cannabis use in adolescents.

Topic: **Ethical Considerations When Working with Domestic Violence Patients**

Description: This training will allow clinicians to navigate several ethical dilemmas currently encountered when working with cases involving Domestic Violence. There will be a specific focus on scenarios related to mandatory reporting and the inclusion in treatment of the parent alleged to have used violence. The training will also focus on clinician beliefs and biases related to victimization across diverse cultures.

Topic: **Behavior Management 2.0 Constructing and Implementing Token Economies**

Description: This program provides clinicians with education on applying behavior management principles to the treatment of externalizing disorders. Program builds on content presented in Behavior Management Theory & Principles, including a deeper dive into implementation of interventions.

Topic: **Evidence Based Treatment of "Moody Kids"**

Description: This advanced workshop is designed to teach the fundamentals of providing psychoeducational psychotherapy (PEP) to youth with depression and other mood disorders in an individual-family (IF-PEP) format. Training will follow the format of materials covered in PEP, beginning with key features of assessment, including differential diagnosis and comorbidity.

Topic: **Treatment Strategies for Patients with High Functioning Autism Spectrum Disorder**

Description: Clients with high functioning ASD can be successfully maintained in typical outpatient treatment settings when practitioners have the knowledge and confidence to do so. Many practitioners already have a great foundational knowledge of CBT, and with some adaptations to typical CBT can lead clients with ASD and their families to successful outcomes. This training will help practitioners to better understand ASD and adapt their current skills to meet the unique needs of children/adolescents with ASD. Learners will increase their comfort and skill with the “B” in CBT and will gain more knowledge of the different programs and services available to help support clients with this diagnosis.

Topic: **Setting up Successful Exposures for Treatment of Anxiety-related Disorders**

A key supervision competency toward this goal is developing fluency in promoting awareness of privilege and implicit bias in ourselves and our supervisees. This training will focus on enhancing supervisors' strategies for continually building awareness of how privilege and bias impacts the relationship between supervisor and supervisee, as well as that between supervisee and patient.
