<u>Topic: Navigating Treatment with System Involved Youth and Caregivers</u> <u>Presenters:</u> Lea Taylor, PhD

Description: Working with youth in the foster care or legal system can pose

unique challenges when it comes to rapport building, engagement,

navigating changes in caregivers/placement, etc. This presentation will

provide practical strategies for navigating these challenges and establishing

a partnership with youth and their caregivers to generate better outcomes.

Topic: Distress Tolerance: Change and Acceptance Presenters: Caroline Hodgson, PhD Description: Dysregulated teenagers are often in desperate need of change to interrupt cycles of self-destructive behaviors, including self-harm, substance abuse, and suicidal behavior. However, many of these same teenagers resist these interventions and struggle to tolerate feedback from caregivers hoping to promote this change. This presentation will incorporate lessons and principles from dialectical behavior therapy (DBT) to promote the fine balance between accepting and validating patients while facilitating necessary behavior changes. Participants will learn specific distress tolerance skills to support their patients in accepting stressors they cannot change and building their capacity to safely outlast negative emotional experiences. Participants will have opportunities to practice these skills through case vignettes and role play exercises. <u>Audience:</u> Advanced (3 CE's) <u>Registration Deadline:</u> Friday February 3rd.

Topic: Emotional Dysregulation: States of Mind and Behavior Chain Analysis Presenters: Caroline Hodgson, PhD Description: Some children and teens are faced with "big emotions" that feel unmanageable at times. This emotional dysregulation can often lead to maladaptive coping behaviors (e.g. self-harm) without effective skills. This presentation will introduce the concepts of Biosocial Theory and States of Mind. Presenters will further discuss Behavior Chain Analysis and how to incorporate into practice when working with this population. Audience: Advanced (3 CE's)
