<u>Topic:</u> <u>Suicide Prevention Myth-Busting Youth Suicide: Applications to Crisis-Focused Intervention</u> Presenter: Caroline Hodgson, PhD

<u>Description:</u> Despite increasing attention to "the problem of youth suicide" and societal investment in breaking stigmas surrounding mental illness, rates of youth suicide have remained stagnant. This presentation will review prevailing theories of suicidal behavior, debunking common misconceptions about predicting and treating suicidal thoughts and behaviors in youth. The presenter will introduce a basic framework for targeting suicidality in brief, crisis-focused psychotherapy. Participants will learn strategies to create the greatest "bang for their buck" in preventing suicidal behavior in their patients.
